Mooncake Festival Promotion

Terms & Conditions

1. Subject to the Terms and Conditions set forth hereinafter (the “**Offer Terms**”) and easyMarkets business terms and policies set forth on the easyMarkets Legal Page clients that meet the criteria set forth hereinafter will be eligible for the Mooncake Festival Promotion 2025 Promotion as defined below.
2. Active Clients who make a net Deposit and complete the required lots of trading volume during the Promotion Period (“**Eligible Clients**”) are entitled to the Mooncake Festival Promotion Prizes as set forth below:
